A 10-storey hotel building with an underground car park for MotelOne and an adjoining 9-storey residential and commercial building with 25 flats and catering space as well as a sky bar with a view of the Karlsruhe castle and the city centre are being built there. The entire property will also have a direct connection to public transport. Completion is scheduled for the 1st quarter of 2023.
