GÖRG Partnerschaft von Rechtsanwälten mbB has advised MDAX-listed Encavis AG on the purchase of a 12.4 megawatt wind farm in the municipality of Desloch in Rhineland-Palatinate. The seller is BayWa r.e. Wind GmbH.

Vestas V-162 wind turbines, each with a nominal output of 6.2 MW, are to be commissioned in the near future. A GÖRG team led by our partner Thoralf Herbold and Dr Ruth Büchl-Winter (Counsel) and Dr Ilka Mainz (Associate Partner) carried out a legal due diligence for Encavis, structured the purchase process and advised on all legal issues in connection with the successful transaction.
