The fund was set up by Ufenau partly for the investment in Altano, on which GÖRG also acted as advisor.

Altano Group is a veterinary clinic group based in Dülmen, which was founded in 2017. The portfolio now consists of 20 clinics as well as 20 affiliated practices with over 330 veterinarians and over 1000 employees. Based on the new financing, the group can continue its successful growth strategy.
